IMPORTANT GUIDELINES FOR PARENTS

- 1. a. Fee must be paid by the 10th of every month.
 - b. After 10, the fee can be deposited with an extra sum of Rs.10/- per day.
 - c. For the non-payment for more than 3 months, the name shall automatically be struck off and the student may be re-admitted by paying Rs. 500/- as the readmission fee.
 - d. Advance payment of fee will be accepted.
- Parents and guardians will kindly save the receipt issued to them and produce as proof of payments of fees, if needed.
- 3. A 20% concession on tuition fees will be provided for all siblings, regardless of order. This discount is applicable only to the tuition fee. No fee concession to the sibling/siblings studying in classes 11th and 12th.
- 4. Examination fee shall be charged twice a year in September and February.
- 5. No student will be allowed to sit for the First term or the II Term examination unless all School bills have been cleared within prescribed time.
- 6. Fees will have to be paid as long as the pupil's name is on roll and any kind of fee once paid cannot be refunded even if the pupil is withdrawn.
- 7. Fee of the months June –July, December-January and February- March will be paid collectively in the months of June, December and February respectively. Partial fee is not allowed for the mentioned months. It is only admissible with an extra sum of Rs. 100/-.
- 8. Gateway charges if applicable as per bank norms will be collected for online payments.
- 9. Those seeking admission in the mid-session shall have to pay the fees from the beginning of the session.
- 10. In case any cheque is bounced, parents need to pay the fee in cash along with the late payment fee for the period and bouncing charges. These cases will be treated equivalent to defaulters of late payment fee.
- 11. Parents need to submit the amount for any kind of extra co-curricular activities in which students participate such as picnic, tour, extra coaching, camps, any charge for Annual day or other functions. In such cases also, a notice will be sent to the parents duly signed by the school authorities. Parents are expected to reciprocate the gestures immediately.
- 12. Parents are liable to pay the transportation charges for the whole session except the month of July, if the transport facility is opted once in a year.
- 13. Extra charges will be borne by the parents if any cash fee is deposited in the bank directly.

THE MANAGEMENT RESERVES THE RIGHTS

- A. To expel a student who fails to make satisfactory progress in his/her studies or whose conduct is in any way detrimental to the discipline of the institution, for immorality, in subordination or contempt, without prior notice to the parents.
- B. To amend policies, rules and regulations without prior notice. In case of any dispute, the matter will be referred to the managing committee and proper hearing will be given to the parents to present their case, the decision of the managing committee will be final and binding.
