- 2. That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. in respect of the said institution.
- 3. That the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
- That the private institution shall employ only the trained/eligible staff as per the norms 4 fixed by the State Govt. before the start of academic session 2021-22.
